All CX bargaining unit members who have signed Teamsters membership application and are members in good standing shall have the right to nominate, second or be a candidate for the bargaining team. Nominations and seconds must be made by CX Bargaining Unit members from your work Location and accepted by the nominee. Nominees may not nominate themselves. Nominators and nominees are encouraged to verify their membership status by contacting their Union Representative. Nominees who accept must read and sign the bargaining committee job description and pledge after the election. Nominations must be received no later than 4:00 PM on July 7, 2021.

Election: The election will be conducted via electronic ballot with all CX Union members receiving a ballot beginning July 12, 2021, with the polls closing at 4:00 p.m. on July 23, 2021. Members shall only be able to vote for candidates from their Location. The highest vote getter for each Location shall be deemed elected to the team, with the 2nd highest vote getter for each Location becoming the alternate.
