### Step Placement, Step Increase & Lump Sum Bonus

#### Congratulations to the AO2 Bargaining Team on Reaching a Tentative Agreement!

Along with the support of our AO2 members and friends, our Administrative Officer 2 (AO2) Teamsters Bargaining Team held the line on improved salary ranges and step increases for AO2s across the State and have come to a Tentative Agreement with the University of California! After more than a year of negotiations and 21 bargaining sessions, we are pleased to recommend a YES vote by members on the agreement which includes:

#### SUMMARY OF TENTATIVE AGREEMENT

- 3% Across the board pay increase received July 1, 2021
- New Union-negotiated pay ranges including pay steps for each location, effective January 1, 2022. Workers will be placed at the step closest to, but not less than, their current pay.
- All AO2s will receive an additional 1-step increase (approximately 2.25%), effective January 1, 2022.
- \$800 Lump sum payment within sixty (60) days of ratification.


Our AO2 Bargaining Team will host an online Town Hall meeting at 12 pm and 6 pm on Thursday, March 3rd, to review the tentative agreement.
