- Shall listen to and take into account the input, feedback and positions of the members whom the committee member has been elected to represent and bring that feedback to the Bargaining Committee in order for it to make informed and fair decisions that take into account the full spectrum of members' interests.
- Shall seek to build consensus among members in regard to contract campaign bargaining issues, positions, demands, campaign strategies, tactics, and actions.
- Shall keep members fully informed of developments in negotiations, including providing timely reports on what has occurred at negotiations sessions, Union and management proposals and counter-proposals, campaign plans, strategies and tactics, and any other relevant information.
- Organize and mobilize members to support and participate in the activities and actions of the contract campaign.
- Shall attend the Teamsters Bargaining Training on August 11-14, 2025.
